Commitment Deposit Required: To reserve your child's placement, a non-refundable commitment deposit of \$150.00 must be paid by May 11, 2018 (for placement offered after April 25, the deposit will be due May 11 or within 5 business days of enrollment acceptance, whichever is later). Assuming your child attends the Rolling Hills kindergarten program throughout the 2018-2019 school year, the commitment deposit will be applied to your student's May 2019 monthly program fee. For those requesting financial-assistance, a completed Request for Extended Day Program Fee Financial Assistance packet may be submitted by May 11 (or within 5 business days of enrollment acceptance) in lieu of the Commitment Deposit. The amount and due date of your commitment deposit payment will be negotiated as part of your assistance package determination. If your Commitment Deposit or financial assistance packet is not received timely, the kindergarten placement will be forfeited and enrollment will be offered to the next child on the wait list.
